Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  We do not share information with non-affiliates.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  Vee do not engage in joint marketing.
